1. License.

"**Gold Version**" means a version of the Tro GPS Simulator, so identified, **to be used under paid license category**. The Gold Version may not have some features and the Gold Version may be converted to the any other Tro GPS Simulator Paid Licensed Version. In which case, and at such time, the Tro GPS Simulator version licensed to you become s other paid versioned license, subject to all of the terms and conditions of Tro GPS Simulator other paid EULA. Although TROSYS at all times owns the Software, you will have certain limited rights to use the Software after your acceptance of all of the terms and conditions of this EULA, which use shall be subject at all times to your compliance with this EULA.
